When our son and daughter-in-law brought us back, we saw that the staff had arranged to have his bed moved into a private room, where there was a bed I could sleep in, to be near him on our last anniversary. It was a very thoughtful thing to do.

They also arranged a special breakfast for us both the next morning. This was only one of innumerable kindnesses shown to us as a family while my husband was ill."
